Based on customer demand, we have decided to simplify and reduce the number of geographical Carrier Haulage locations available in our product catalogue. Effective 15 September 2013, our Carrier Haulage offering will only cover the following 'store door' receipt/delivery locations:

Auckland city limits

- Christchurch city limits
- Bluff
- Timaru

Service changes

South Atlantic Express – Service changes

In an effort to further optimise our South Atlantic Express service and better serve our customers, we are making the following changes with effect from the Varamo sailing southbound from Savannah (Georgia, US) on 15 August 2013:

- Removal of the Miami (Florida, US) port call from the rotation. The last call in Miami (Florida, US) will be the Islandia/1327 sailing from Miami on 14 August
- Addition of a fourth vessel to the rotation to ensure unchanged transit times and space availability remains the same for cargo already utilising this service
- Addition of a direct coverage between N. Colombia (Santa Marta, Barranquilla, and Cartagena), Costa Rica, Guatemala, Honduras, and the United States

The new port rotation will be: Savannah (Georgia, US) – Norfolk (Virginia, US) - Wilmington (North Carolina, US) - Santo Tomas (Guatemala) - Puerto Cortes (Honduras) - Puerto Moin (Costa Rica) - Manzanillo (Panama) - Cartagena (Colombia) - Barranquilla (Colombia) - Santa Marta (Colombia) - Manzanillo (Panama) - Santo Tomas (Guatemala) - Puerto Cortes (Honduras) - Savannah (Georgia, US)

SAECS Service - Change of UK Terminal

With effect from Week 45, SAECS Service member lines – Maersk Line, Safmarine, MOL and DAL have decided to move their UK call from the London Container Terminal Tilbury to the new London Gateway Terminal.

The first vessel is planned to call at London Gateway in week 45. With this

change of terminal, Shipping Lines aim to secure benefits for their customers through the new infrastructure (such as improved rail connections) and access to UK markets. In addition, the operational advantages will assist us in maintaining schedule reliability, enabling customers to create better efficiencies in supply chains.

MOL Caledon / voyage 137A- First new London Gateway terminal (LGW) in week 45.

New rotation:

London Gateway (LWG) replacing Tilbury (TBY) in the usual SAECS rotation.
